Accidental injection with this oil-based product, even in small quantities, can cause intense swelling which may, for example, result in ischaemic necrosis and the loss of a digit. Expert PROMPT, surgical attention is required and may necessitate early incision and irrigation of the injected area, especially where there is involvement of finger pulp or tendon.

**Specific treatments**: In case of accidental self-injection of oil emulsion vaccines, get medical attention

immediately.
